WHEREAS, this Council has duly reviewed and considered said March 25, 2002 version of the  
subject budget;

NOW, THEREFORE, IT IS HEREBY DETERMINED AND ORDERED, as follows:

1. That consent of this City Council is hereby given to the Sewer Authority Mid-Coastside for it to  
approve and adopt its Collection System Budget for Fiscal Year 2002-2003, with the City's  
share of \$80,729.00 as shown in the March 25, 2002 version of the Fiscal Year 2002-2003  
SAM Budget.
2. If the Sewer Authority Mid-Coastside makes provisions or takes action that reduces the  
operating or capital costs of the collection system, then the Authority will reduce the City's  
share of the budget accordingly, and
3. That the City Clerk shall transmit a copy of this Resolution to the Sewer  
Authority Mid-Coastside.



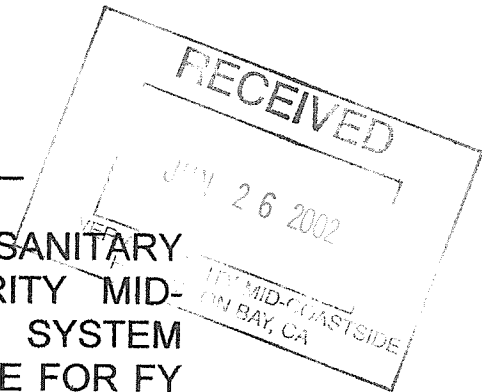
