

RESOLUTION NO. 10-93

A RESOLUTION TO REDUCE THREE CITY OF HALF MOON BAY
PERMITTEES' FISCAL YEAR 1992-93 NON-DOMESTIC WASTE SOURCE
CONTROL PROGRAM FEES DUE TO FLOW REDUCTIONS

RESOLVED, by the Board of Directors of the Sewer
Authority Mid-Coastside (Authority), San Mateo County,
California, as follows:

WHEREAS, this Board did, by its Resolution No. 4-92
establish a schedule of Permit Fees for use in conjunction
with the Non-Domestic Waste Source Control Program for
Fiscal Year 1992-93 (Program Fee Schedule);

WHEREAS, this Program Fee Schedule included a
methodology for calculating fees based on water consumption
flow rates provided by the Authority's Member Agencies;

WHEREAS, this Board has been advised that Member
Agency, the City of Half Moon Bay has provided reduced flow
rates for three Program Permittees, Half Moon Bay High
School (Permit No. HR020), the Happy Cooker Restaurant
(Permit No. HR008), and Round Table Pizza (Permit No.
HR015);

WHEREAS, this reduction in flow rates, according to
Program Fee Schedule calculation methodology, necessitates a
reduction in the above Permittees' Program Fees;

NOW THEREFORE, IT IS FOUND, DETERMINED AND ORDERED
that:

1. The revised flow and Program Fee information for
the Half Moon Bay High School, the Happy Cooker Restaurant
and Round Table Pizza, set forth in Exhibit A hereto, is
hereby adopted as a revision to the Program Fee Schedule.

2. The Secretary is hereby authorized and directed to
transmit a copy of this Resolution to each Member Agency.
