

RESOLUTION NO. 2-96

**A RESOLUTION CALLING A HEARING FOR CONSIDERATION OF  
ENFORCEMENT ACTION AGAINST DISCHARGERS THAT HAVE NOT PAID NON-  
DOMESTIC WASTE SOURCE CONTROL PROGRAM FEES FOR FISCAL YEAR  
1995-96**

RESOLVED, by the Board of Directors of the Sewer Authority Mid-Coastside, San Mateo County, California, as follows:

WHEREAS, this Board did, by its Resolution No. 1-91, adopt regulations establishing a Non-Domestic Waste Source Control Program ("the Program");

WHEREAS, such regulations authorized this Board to establish a uniform schedule of fees to be imposed upon and collected from applicants or dischargers to defray the costs of processing and issuing permits in conjunction with the Program and carrying out the services which are a part of the Program (Program Fees);

WHEREAS, such regulations state that it is unlawful to discharge non-domestic wastewater into the sanitary sewer without first obtaining a NDWSCP permit from the Authority and that the permit will not be issued until all applicable fees are paid;

WHEREAS, such regulations state that the Authority may take enforcement action against premises which are discharging in violation of the NDWSCP regulations;

WHEREAS, this Authority did by its Resolution 19-95 adopt Program Fees for Fiscal Year 1995-96;

WHEREAS, all dischargers subject to Program Fees for Fiscal Year 1995-96 have been notified of the fee amount due, and that the fee was due on or before December 31, 1995.

WHEREAS, all dischargers delinquent in payment of such Program Fees have been notified;

WHEREAS, certain dischargers have still not paid such Program Fees.

NOW THEREFORE, it is determined and ordered that:

1. This Authority shall hold a hearing for consideration of enforcement action against dischargers that have not yet paid NDWSCP Fees for Fiscal Year 1995-96, on March 25, 1996, 7:30 p.m., at the Sewer Authority Mid-Coastside Administrative Office, 1000 North Cabrillo Highway, Half Moon Bay.
2. The Secretary of this Authority is hereby directed to give notice of the hearing by posting a certified copy of this Resolution at the regular places for posting notices by this Authority at least 10 days prior to said hearing. Such places are:



3. The Secretary of this Authority is further directed to mail by 1<sup>st</sup> class mail postage prepaid a copy of this resolution to each discharger, and discharger property owner, that has not yet paid Program Fees for Fiscal Year 1995-96. Such mailing shall be made at least 10 days prior said hearing.




Resolution 2-96 was posted in public posting places, to wit:
