A RESOLUTION AMENDING RESOLUTION NO. 3-79  
ENTITLED "A RESOLUTION APPROVING PLANS AND  
SPECIFICATIONS, CALLING FOR SEALED PROPOSALS  
AND PROVIDING FOR NOTICE THEREOF", AS AMENDED

SEWER AUTHORITY MID-COASTSIDE  
PROJECT UNIT 4:  
OCEAN OUTFALL AND PUMPING FACILITIES

RESOLVED, By the Board of Directors of the Sewer Authority  
Mid-Coastside, San Mateo County, California that

WHEREAS, this Board did on March 14, 1979 adopt the resolu-  
tion cited in the title hereof, and said resolution has been  
previously amended by Resolution No. 5-79, adopted on March 28,  
1979; and

WHEREAS, it appears that the public interest, convenience  
and necessity will be served by an extension of the time therein  
provided for the receipt of bids and the consideration thereof  
by this Board;

NOW, THEREFOR, IT IS FOUND, DETERMINED AND ORDERED as  
follows:

1. A change in the dates fixed for the receipt of bids  
and the consideration thereof by this Board are in the public  
interest in that it will permit the broadest possible participa-  
tion in bidding.

2. Paragraph 7 of the Resolution cited in the title hereof  
is hereby further amended to read as follows:

"7. Said sealed bids shall be delivered to the  
Manager of the Authority on or before 2:00 o'clock p.m.  
on the 16th day of May, 1979, at the City Hall, City of  
Half Moon Bay, 501 Main Street, Half Moon Bay, CA 94019.  
Bids will be publicly opened, examined and declared on

"said day and hour, and referred to this Board of Directors at its meeting at 8:00 p.m. on May 30, 1979."

3. The Manager is hereby directed to give Notice to Contractors of the change in the bid opening and the consideration of the bids by the Board by publishing same two times, not less than five days apart, in the San Mateo Times, a newspaper of general circulation in the Authority and the newspaper within which Notice Inviting Bids was heretofore directed to be given, the first publication to be at least ten (10) days before the opening of bids.


